Buriton Parish Council has the following comments to make on this application:

There is a lack of information and no design statement, so it is difficult to be sure of what we are commenting on.

There does appear to be a large amount of glazing. Buriton including Ditcham lies within the SDNP International Dark Skies Reserve. We form a sensitive pinch point in the reserve and any light spillage can threaten this important status. We therefore ask that the glazing has conditions attached to use automatic blinds or low light transmitting glass to minimise any extra light in this area.

Stanbridge Farm GU315RB

Change of use from Agricultural to mixed use.... Seasonal Glamping May to September.

Buriton Parish Council OBJECTS to this application.

It is difficult to comment on the majority of aspects of this proposal as the information provided is not clear and important issues are not covered.

In Particular we have the following concerns and comments:

1. Parking

The proposed parking is open to view.... This spoils the 'hidden nature' of the tents themselves by interfering with the pleasant views from the footpath running through the proposed site. Will 11 spaces be enough? Has this taken into account the 'on site supervision' and the possibility of more than one car per tent?

2. Rights of Way

Buriton Footpath 26 runs through the site. No mention of this has been made and is an important consideration in this application.

3. Environmental Health

We would like to see notice taken of potential noise issues coming from this site. It is not enough to limit amplified music after 10.00pm. There should be 'No Noise' after 10.00pm.

4. Dark night Skies

Buriton is a vital pinch point in the SDNP International Dark Skies reserve. This application will see increased levels of lighting over night in this sensitive area. Lights are needed for providing after dark access to toilets and shower blocks..... This is unacceptable to us.

5. Ecology.

There should be a proper management plan covering all aspects of ecology on this sensitive location. The site is historically known as the 'Water Meadows. This might well imply underground water sources. These details need to be understood. There will be water runoff from showers.... Where is it going? How often will 'Porta loos" be emptied? What are the traffic implications for the vehicles needed to deal with this? Most worryingly, there is talk of hot tubs. They will contain Chlorinated water. Where will they be emptied? How will this be managed?

This may well be an opportunity to improve the woodland site, but with no information how will this be achieved?

How will outdoor fires/ BBQs be managed?

There is no information covering these aspects. The Parish Council has no alternative other than to **Object** to this application.

SDNP/18/04008/HOUS

The Old Hopkiln GU315SE

To create a 4-meter-long corridor linking the house to the garage.

Buriton Parish Council has the following comments to make on this application:

We are pleased to see that the light spilling from this new link building has been minimised. The building does not appear to be visible from the footpath and the design is in keeping with the existing buildings. Thus, it is working within the guidelines of the Village Design Statement.

We ask that any comments from neighbours are given due weight.

The Parish Council has **no objection**.

SDNP/18/03797/DCOND

The attention of the Parish Council has been drawn to this application and Councillors have resolved to **object** to the proposals and to ask that this current process should be stopped.

However, the Parish Council does not understand why it has not been consulted on this matter. The local community is always likely to have views on planning matters and, in this instance, may have important knowledge about the history of the site and ideas for the future.

The Parish Council's concerns about this application relate to the potential demolition of the old lime kilns.

The Parish Council has seen the submission made to you by the Buriton Village Association (dated 25th October), agrees with all the points that the Association has made and encourages you to consider all those matters very seriously.

In addition, the Parish Council makes the following points:

- Are there many (any?) kilns like this anywhere else in the National Park?
- Retaining at least parts of these kilns would give an opportunity to inform (and educate) visitors to the area about the cultural and industrial heritage of the area – linked to the underlying geology – which is something which should be important in a National Park
- The site is immediately adjacent to the Queen Elizabeth Country Park which is already a popular recreational
 asset. Adding interpretation about the area's cultural and industrial heritage alongside the Country Park could
 be a very valuable amenity opportunity as part of the future restoration and landscaping of the quarry site
- The site could be well-served by public Rights of Way as there are routes to both the west and east of the site with connections to and from the Country Park; enabling easy access on foot and by cycle
- The Council suspects that it may be possible to save at least one of the pairs of kilns (perhaps concentrating on its façade)
- All opportunities to retain at least parts of these kilns must be fully explored through a wide range of potential options.

The Parish Council hopes that this application	will be refused and that the	local community can take	part in discussions
about the future of these important lime kilns.

6. Public comment on the above applications

Letter from Buriton Village Association dated 25 October 2018.

Dear Planners

Potential demolition of lime kilns at Butser Chalk Quarries: SDNP/18/03797/DCOND

The Buriton Village Association has learnt that there may be a proposal to demolish some existing, historic lime kilns as part of this application (SDNP/18/03797/DCOND) – but the local community does not appear to have been consulted.

Our organisation coordinates the well-regarded Buriton Heritage Bank initiative and we have information about, and interest in, these remaining lime kilns. These structures provide a direct link to the past, with the local industries of yesteryear and with the underlying geology of the chalk downs which is at the heart of the National Park's landscapes.

Should this application go unchallenged there is a danger that the future of the kilns could be determined through a minor amendment to an existing Condition on a planning permission: it is far more important than that.

Not only do these kilns feature in the personal stories of local residents on our community website but are a significant contribution to the story of our local landscape and industry: see http://buriton.org.uk/history/butser-lime-works-mr-chittys-story/

The relative importance of these particular kilns has long been recognised in a number of learned surveys and studies – including those by the University of Southampton's Industrial Archaeology Unit.

It is our view that these kilns should not be demolished without a more widespread consultation and consideration of a wide range of alternative options which could preserve at least parts of the structures. If you have not already done so, we suggest you consult with experts at places like the Weald & Downland Living Museum to consider all options to ensure these valuable local assets are not lost for the future.

As an important feature of our industrial heritage they could (or parts of them could) be preserved for, and included in, the final scheme for these quarries – when the area is restored after extraction and waste disposal has been completed. Interpretation materials could be provided so that residents and visitors could learn and appreciate more of the South Downs' heritage.

We trust that this application to amend Conditions (so that these kilns can be demolished) <u>will be refused</u> and we would be happy to work with you and / or the applicants to develop better proposals for the future.
